8,	Drawl of Pension	The retired Government official selected as Consultant shall continue to draw pension and the dearness relief on pension during the period of his engagement as per extant rules. His/her engagement as Consultant shall not be considered as a case of reemployment.		
9.	Remuneration	A fixed monthly amount will be admissible, arrived at by deducting the basic pension from the last pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract. There will be no annual increment/percentage increase during the contract period.		
10.	Tax deduction at source	Consultant shall be eligible for eight (08) days of leave in a calendar year on pro-rata basis.  No remuneration for period of absence in excess of the admissible leave will be paid.  TDS admissible shall be deducted from the monthly.
