- 4. Vide this office letter no. NYKS/Core Prog./2021-22/168 dated 8th February 2022, suggestive activities and list to celebrate the remaining days & weeks in a grand & befitting manner was shared. International Women's Day is one of the suggestive Days.
- 5. Suggestive Programmes and Activities in the run up to IWD and on IWD itself:

Each District NYK while celebrating the IWD, may undertake activities out of the following suggestive list with active involvement of NYVs and NYKS affiliated village based Youth Clubs:

- Discussions-cum-workshops on women based issues during the week.
- Photograph campaign with crossed arms (commit to Breaking the Bias) & uploading them on various social media platforms
- Showcasing of outstanding initiatives of women & felicitating them
- Theme based Seminars/Workshops
- Knowledge Competitions- Debate, Essay writing, Declamation, Painting competition

6. Coordination:

- NYKS Youth Club Members should be motivated to organize similar types of activities in their villages in coordination with Mahila Mandals, SHGs, Gram Panchayat and other Stakeholders.
- b) Wherever needed, activities should be held in coordination with State/District/other bodies.

7. Target:

National Youth Volunteers should be given target to motivate a minimum of 20 village based Youth Clubs in their respective blocks for conducting above mentioned activities.

8. Participation:

Participation of maximum number of people in general and youth in particular from all sections of society should be ensured.
