**Subject: One day training of Deputy Director(s), District Youth Coordinators and 100 Youth Volunteers on Investor Awareness Programme on 10<sup>th</sup> September, 2019 at Bhubaneswar, Odisha**

1. NYKS has agreed to undertake Investor Awareness Programme in collaboration with Investor Education and Protection Fund Authority (IEPFA) on pilot basis.
2. The objective of the programme is to sensitize the people in general and youth in particular about IEPFA and Investor Awareness Activities undertaken by the Authority. The educated youth will in turn mobilize their peer and village communities and generate awareness in financial literacy and investments.
3. To start with, State level Conference and Awareness Programme is scheduled to be held on 10<sup>th</sup> September, 2019 in which all Deputy Director(s) , District Youth Coordinators and 100 NYKS Youth from all District NYKs in Odisha will take part.
4. The IEPFA will arrange resource persons for imparting training.
5. The programme will be graced by Hon'ble Governor of Odisha and other high officials of Central as well as State Government. A copy of the tentative Programme schedule and e-Invite is **enclosed** herewith.
6. For this purpose, an amount of **Rs. 2,45,000/-** have been sanctioned and will be released shortly. Since the time is very short, therefore, expenditure should be made as per enclosed Head wise Budget details. It also includes TA/DA of NYKS Deputy Directors, and District Youth Coordinators. Therefore, it should not been claimed for NYKS funds. GFR and other codal formalities should be maintained.

Selected Youth Volunteers should book their tickets in such a way that they reaches Bhubaneswar on **9<sup>th</sup> September, 2019 by lunch and leave Bhubaneswar on 11<sup>th</sup> September, 2019.** The arrangements for youth volunteers should compliment with the amount of funds provided.
  - b) Make necessary boarding and lodging arrangements for 100 youth participants as well as of Deputy Director/ District Youth Coordinators.
  - a) TA/DA should be paid to Youth Volunteers as per actual subject to ceiling Rs.600/- per head.
  - b) Banners, Standee, etc. should be displayed near the venue of the programme.
